## **Chairperson's Report**

- Chairperson thanks the daily hard work of the staff, especially the Executive Staff. Staff's work is incredibly helpful in supporting the work of the Board of Commissioners.
- Thank you to the Commissioners for their assistance with the Commission Retreat in September, 2019. Also, thank you to Commissioners Duke and Levitt for their support in selecting the appointees for the Western Maryland Advisory Council.
- The January, 2020, Commission meeting will be at the Maryland State Library for the Blind.
- We are very excited for the April 25, 2020 Gala in recognition of the 100<sup>th</sup> anniversary of women's suffrage as well as the 30<sup>th</sup> anniversary of the Americans with Disabilities Act.
- Being installed as a Worshipful Master of a Masonic Lodge. Very honored and humbled by the opportunity.
- Retired partner guide dog Pilot has passed away.

#### **Executive Director's Report**

• Reminder: Gala is scheduled for April 25, 2020. MCCR circulated a Save the Date in November, 2019. The original keynote speaker had a scheduling conflict and had to back out. However, Dr. Mary Francis Barry, former Chairperson of the U.S. Civil Rights Commission, has been contracted as the Gala's keynote speaker. The attendance goal is 500 and MCCR is confident that our hard work can help to meet this goal. Executive Director is respectfully requesting Commissioners secure one table a piece at the Gala. One table of general admission tickets is \$750 (10 tickets at \$75 per ticket) and one table of VIP admission tickets is \$1250 (10 tickets at \$125). VIP tickets will have certain perks, including a reception with Dr. Barry. Staff could also use some support from Commissioners in identifying and securing sponsorships for the event. The Gala will also feature a number of women honorees who highlight many of the civil rights efforts and successes in Maryland.

- Western Maryland Advisory Council had a follow-up video teleconference in December. Three areas of focus: diversity, equity, and inclusion; hate/bias reporting; civic engagement. WMAC will be meeting on these focus areas in the beginning of 2020. They will also be electing their leadership in the first quarter of 2020. WMAC is moving forward full steam ahead.
- The Maryland Equity & Inclusion Leadership Program graduation occurred last week. It was an outstanding success. Over 30 individuals graduated in this second cohort. The level of excitement and enthusiasm for the program from the cohort was incredibly refreshing. MEILP should be viewed as one of MCCR's signature programs. The agency needs to continue to build upon the opportunity of this program.
