# Chairperson's Report

- Chairperson opened the meeting with the Pledge of Allegiance, and asked Commissioner Marwick to provide a non-sectarian affirmation and reflection to open the year.
- Chairperson thanks the Maryland Library for the Blind & Physically Handicapped for serving as host.
- Chairperson reviewed the agenda.
- Chairperson provided the following remarks: "As a Board, we have a goal to have as many of the monthly meetings "on-the-road" as we are able. When the Vice Chair and I met with the Secretary of Appointments, this was a point stressed to us. IN 2020, I look forward to holding our meetings in the public eye. (As we are able.)

As a lawyer and as a blind person, I am incredibly thankful to our guest host who provides an array of services to those who cannot read standard print.

So, there cannot be light without learning. There cannot be learning without liberty. There cannot be liberty without access to information.

As someone who loss vision regularly and steadily during a trajectory of time from my youth through my adulthood, I know the challenges some encounter in accessing information. Since a lad, when I could no longer read the newspaper or other forms of standard print, I have dreamed of being as other citizens who can simply walk into a library and pull books from the shelving units. I stopped being able to access the newspaper when I was in second grade. Then, as a lad, I received my first recorded volume from the Library for the Blind – as located in Cleveland, Ohio.

On the other hand, I also know the thrill of contributing to the world of letters. (Indeed, I have contributed notably to the world of letters despite my disability.) However, I would not be able to access information and the world of letters without the greatness of this republic that provides resources, such as the Md. State Library for the Blind.

For among other reasons, this is why I also love libraries and museums. We are fortunate in this republic to have an incredible resource of the Library of Congress and an array of state-based distributing libraries. For the blind, this is even truer. (As you will learn.) Resources, such as the State Library for the Blind, provide me the ability to access information and books.

So, we will hear guest briefings by two co-speakers today. There will then be a tour."
