Chairperson's Report

The Commission has forwarded their recommendations for the Executive Director position to the Governor.

The Chair reminded everyone that the Gala is approaching, and Commissioners should be active and responsive towards requests made for the Gala.

The Chair introduced the new Commissioner, Noah Metheny, Esq.

Acting Executive Director's Report

The Acting Executive Director began by thanking staff for their diligent work amid MCCR's state of transition.

In June, MCCR held its first Fair Housing Task Force meeting where all the fair house organizations throughout the state meet to discuss issues impacting fair housing. This recent meeting's topic was the issue of source of income. There was a presentation by the Equal Rights Center's Susan McClanahan to review what source of income is and, from an enforcement perspective, how to enforce source of income discrimination.

The Acting Executive Director has been asked to participate in the Fair Housing Enforcement Work Group for the 2025 Baltimore Regional Fair Housing Analysis.

The Maryland Association of Human Rights Agencies (MAHRA) and the Equal Employment Opportunity Commission (EEOC) is hosting a Civil/Human Rights Conference. The purpose of this conference is to bring together all respective staff and Commissioners to engage in a day of training. A venue is currently being selected.

The Acting Executive Director reviewed the Case Processing report. Some things that were highlighted:

- The housing unit closed 179 cases, surpassing last year's closure number.
- MCCR is on pace to satisfy its EEOC contract.

General Counsel's Report

The General Counsel highlighted a few points from the Unit's written report.

The Office of the General Counsel will bring onboard another Assistant General Counsel I to the team.

The Office of the General Counsel will be conducting Investigation Techniques and Legal Theories Training for Statewide EEO Office on July 17 & 18, 2024.

The General Counsel will serve as a panel moderator for MCCR Cannabis Symposium.
